As a Syracuse University student enrolled in the Student Health Insurance Plan, you have access to Aetna's Teladoc services. Teladoc is a way to be treated for non-severe medical issues without having to physically visit a provider's office. Through Teladoc, you can be treated for all of the following:

- General Medical (24/7 care by web, phone or mobile app): Cold & flu, allergies, bronchitis, sinus infection, rash, sore throat, skin problems, and respiratory infections.
- Behavioral Health (video appointments available 7am-9pm seven days a week): Support for anxiety, eating disorders, depression, and family issues.
- Dermatology (log into your Teladoc account to upload images to get started): treatment for complex issues such as psoriasis, eczema, and acne.
